Part 3: Important Information

* Use of screen reader application category: Candidates with a screen reader reasonable accommodation request must receive pre-approval by CalMHSA, prior to scheduling for the exam. The use of JAWS® screen reader software is required by Pearson VUE (proctor) for on-line and in-person testing. For on-line testing, candidates are responsible for having the JAWS screen reader software prior to the start of the exam. For in-person test, the JAWS® screen reader software is available at no-cost to candidate with pre-approval by CalMHSA. The candidate is responsible for knowing how to use the screen reader software. **CalMHSA is not responsible for the provision of JAWS software or training on how to use the software.** The proctor is NOT permitted to guide the candidate through how to use the screen reader software. Candidates must contact the proctoring agency (Pearson Vue) to confirm the reasonable accommodation, prior to the exam date. *** Details for "other" category: Specific information must be entered in this section. The information must be legible. CalMHSA shall review the accommodation requested and may contact the candidate directly for further inquiry. Candidates may be required to contact the proctoring agency (Pearson Vue) to confirm the reasonable accommodation, prior to the exam date.

** Details for "Sign Language Interpreter" category: A sign language interpreter will be present to only facilitate communication with test center staff and will not be allowed in the testing room.

**** Personal assistant: A personal assistant is a person that will be present during the exam, to provide assistance with the accommodation as specified above. A personal assistant may not answer or explain any content-related questions. Except for the Translator and Sign Language interpreter, the candidate will provide their own personal assistant. In-person exam must be delivered in a separate room. For online exams, additional forms are required to be completed by the personal assistant prior to the candidate scheduling the exam. CalMHSA will provide the additional forms to candidates.

Part 4: Submission of Form.

1. Request must be made using this form. Additional supporting documents may be submitted along with this form, if desired.
2. Requests will be processed only for individuals with an approved application for examination.
3. Request form pages numbered 1-6 must be submitted to CalMHSA via your certification application or by mail at least 30-days before the desired testing date. The 30-day timeframe starts from the date of the approval of the application for examination.

4. CalMHSA will review all complete reasonable accommodations requests and will notify the applicant of the status of the request for exam accommodations within 30 days from the date the request was made. Applicants will be notified via email on file on the application for examination.

Part 5: Comfort Aid List - The following list of items do NOT require an accommodation request

Medicine & Medical Devices

- Auto-Injector, such as EpiPen
- Bandages
- Braces – Neck, Back, Wrist, Leg or Ankle Braces
- Casts – including slings for broken/sprained arms and other injury-related items that cannot be removed.
- Cough Drops – must be unwrapped and not in a bottle/container.
- Eye Drops
- Eye Patches
- Eyeglasses, without the case, including tinted lenses – must be removed for visual inspection
- Glucose Tablets (does not include hard candy) – must be unwrapped and not in a bottle/container.
- Hearing aids/Cochlear implant – See additional information below.
- Inhaler
- Medical Alert Bracelet – See additional information below.
- Medical device – Must be attached to a person’s body and be inaudible. If device makes noise, then candidates must apply and be approved for an accommodation. See additional information below.
- Continuous Glucose Monitor
- Insulin Pump
- Spinal Cord Stimulator
- TENS Unit
- Medical Foot Stool – Note: Candidates may bring a medical foot stool for the purpose of supporting an injured leg or foot. The stool must be non-skid, have a metal base, and can be no larger than 14X14X12.
- Nasal drops/spray
- Oxygen Tank – Must be self-contained and silent. If the oxygen makes noise, or if power is required, then accommodation approval is needed.
- Pillow/Cushion
- Pills – i.e., Tylenol or aspirin – Must be unwrapped and not in a bottle/container. Note: Candidates may bring pills that are still in the packaging if the packaging states they **MUST** remain in the packaging, such as nitro glycerin pills that cannot be exposed to air. Packaging must be properly inspected.

Additional Information: Candidates are not permitted to plug any device into the computer workstation. If the medical device includes an accompanying external remote-control device, the remote-control device may **not** be taken into the testing room. If there is a need to take the external remote-control device into the testing room, including a cell phone, candidates must apply and be approved for an accommodation request to do so. - Earplugs and Noise Reducing Headphones. In person exam only and provided by test center. If ear plugs are required for online testing, please submit a Reasonable Accommodation Form.
- Face mask and/or gloves. In person exam only. Not permitted for online testing.
- Magnifying glass. Approved, handheld, non-electronic, without the case.
- Tissues/Kleenex. Must be provided by the test center for in-person exam.
- **New!** Adjustable font size: Ctrl+/- can be used to adjust font size. Ctrl+ will enlarge font up to 2x (20–24-point font.) This is available to all test takers, so approval is no longer needed.
